Main Authors

Jannis J. Grimm is a Research Associate at the Institute for Protest and Social Movement Studies in Berlin (ipb) and at the Center for Middle Eastern and North African Politics at Freie Universität Berlin (FUB). He holds a PhD from the Berlin Graduate School Muslim Cultures and Societies. Since 2019, he coordinates the Friedrich Ebert Foundation's trade union work in the MENA region and the foundation's country project on Libya. He has spent several years investigating processes of authoritarian contraction and social mobilization in Egypt and Turkey at the German Institute for International and Security Affairs, SWP Berlin, SNS Florence and the FUB. He has conducted extensive fieldwork in the Middle East & North Africa and has served as a consultant to the German Federal Government as well as several human rights organizations and political foundations.

Kevin Koehler holds a PhD from the European University Institute (EUI) in Florence, Italy, and is an Assistant Professor at Leiden University, where he teaches comparative and Middle Eastern politics. He previously taught at the American University in Cairo (AUC) as well as the NATO Defense College (NDC) in Rome. His research focuses on the Arab world, with a particular emphasis on civil-military relations, authoritarian regime dynamics and conflict processes. He has conducted fieldwork in Egypt, Tunisia, the Turkish-Syrian border area, Yemen, as well as Kyrgyzstan, and has served as a consultant for several organizations, including

NATO, the United Nations Development Programme, the UNHCR, and the German Federal Ministry for Economic Cooperation and Development.

Ellen M. Lust is the founding director of the programs on Governance and Local Development at Yale University (established in 2013) and at the University of Gothenburg (established in 2015), and is a professor in the Department of Political Science at the University of Gothenburg. Ellen has conducted fieldwork and implemented surveys in Egypt, Jordan, Libya, Malawi, Morocco, Palestine/Israel, Syria, and Tunisia, supported by such foundations as the Social Science Research Council and the Swedish Research Council. She has led large-scale writing and research projects, collaborating with more than 30 researchers, and has organized over 15 international conferences and workshops in the past 10 years. She has served as an advisor and consultant to such organizations as the Carter Center, Freedom House, the National Democratic Institute, United Nations Democracy Fund, United Nations Development Programme, United States Agency for International Development, and the World Bank.

Ilyas Saliba is a research fellow in the Democracy and Democratization department at the WZB Berlin Social Science Center and PhD candidate at the Berlin Graduate School for Social Sciences at Humboldt University Berlin. In 2019 he joined the Global Public Policy Institute as a research associate, where he works on a dedicated index to measure academic freedom infringements across the globe. He has over two years of fieldwork experience in Morocco, Egypt, and Tunisia. In the course of his research on decision-making in authoritarian regimes during crises, he has been a visiting researcher at the American University in Cairo, the École de gouvernance et d'économie in Rabat, the European University Institute in Florence, and the University of Oxford's Nuffield College in the United Kingdom.

Isabell Schierenbeck is Professor in Political Science at the School of Global Studies (SGS), University of Gothenburg, Sweden. Her research focuses on democratization and political leadership, the Israeli–Palestinian conflict, and Israeli domestic politics. She has also been conducting research on international development cooperation and national ownership in Ethiopia and Rwanda, as well as the right to mental health in Rwanda and South Africa. She has a long-lasting interest in issues on research ethics and safety. She gives lectures and consultations as an expert on Middle Eastern politics.

Co-Authors

Emma Beals is a New Zealand-born journalist and policy advisor whose main focus is Syria. While assisting colleagues in danger in Syria, she co-founded the Frontline Freelance Register and the ACOS Alliance, which both strive to improve safety and security for freelance journalists working on dangerous assignments. She received the 2017 Foley Legacy Foundation World Press Freedom Award for this work. She is also on the Frontline Club and Hostage US Advisory Councils.

Osama Diab is a journalist and an economic rights researcher at the Egyptian Initiative for Personal Rights. He holds a PhD from the Department of Conflict and Development Studies at Ghent University.

Florian Kohstall is in charge of university cooperation with the Middle East and North Africa at the Center for International Cooperation at Freie Universität Berlin and is the head of Academics in Solidarity, a transnational mentoring program for at risk and refugee scientists. From 2010 to 2015 he directed the Freie Universität's Cairo Office at the German Science Center (DWZ). Kohstall holds a PhD on Higher Education and Reform Policies in Egypt and Morocco. He has been teaching political science in Aix-en-Provence, Lyon, and Cairo. His latest publication is a collective volume on *Academia in Transformation: Scholars Facing the Arab Uprisings* (Nomos 2018).

Sylvain Lefebvre holds a PhD in International Politics from Aberystwyth University. He has been working as a Senior Adviser for Protection International for the past six years, delivering workshops and leading consultancies on security management and protection for human rights defenders, civil society organizations and international NGOs. Previously, he served as security officer for Peace Brigades International in Colombia. He has worked in remote and volatile contexts, such as Palestine and Israel, Chad, Kenya, Ethiopia, the Democratic Republic of Congo, and Cameroon.

Daniel T. R. Masterson is a Postdoctoral Fellow at the Immigration Policy Lab at Stanford University, California. He studies migration and refugee crises, conflict, and aid. He has a PhD in Political Science from Yale University, an MPP from Harvard's Kennedy School, and a BA in Political Science from Bates College.

Morana Miljanovic is a freelance researcher, educator, and activist. As a researcher, she focuses on exploitative systems that suppress individual and community freedoms, such as the surveillance industry and border regimes. As a digital security trainer, she seeks to raise awareness about the non-transparent mechanisms of tracking and profiling, and devises strategies that allow human rights defenders to do their work in a safer way. Morana also teaches sailing and partakes in Sea Watch missions, rescuing persons in distress at sea.

Sarah E. Parkinson is the Aronson Assistant Professor of Political Science and International Studies at Johns Hopkins University, Baltimore. She received her PhD in political science from the University of Chicago. Grounded by social network theory and ethnographic methodologies, her research examines organizational behavior and social change in war- and disaster-affected settings, focusing on the Middle East and North Africa. Parkinson has conducted extensive fieldwork in Lebanon and Iraq. She has published scholarship on military organizations' decision-making and internal dynamics, political violence, forced migration, ethics, and research methods. Additionally, she is a co-founder of the Advancing Research on Conflict (ARC) Consortium.

Mara Revkin studies how legal systems operate in and are transformed by war through multi-method research designs that include field experiments, door-to-door surveys, interviews, and social media data. Her dissertation examined the Islamic State's system of governance in Iraq and Syria and its post-conflict consequences. Her current research aims to contribute to the development of evidence-based strategies for strengthening the rule of law and state legitimacy after war, with a particular focus on Iraq. She holds a PhD in Political Science from Yale University and a JD from Yale Law School.

Alessandra Russo is a Research Fellow at the Université Libre de Bruxelles, Belgium. She held previous appointments in France, Italy, and Germany. Since 2016 she has been reflecting on issues of safety and security of researchers traveling to zones which are considered dangerous and at risk. She has been part of a university taskforce to design a comprehensive fieldwork research policy and has recently co-authored book chapters on universities' duty of care *vis-à-vis* their research staff in missions abroad as well as on the (bio)politics of safe research in violent and illiberal contexts.

Francesco Strazzari is a Professor of International Relations at Scuola Superiore Sant'Anna (Pisa, Italy) and an adjunct research professor at the Norwegian Institute of International Affairs (NUPI). He specializes in conflict and security studies, focusing on extra-legal governance, transnational organized crime, terrorism, and armed groups.

Vasilis Ververis researches the technical implementation of internet censorship, surveillance, information controls and network interference. Parts of the research include the technical development of network measurement tools and methodologies to better evaluate and detect tampering or any network interference that may result in information controls, internet blocking, and unintended surveillance.
